## ORDINANCE EXTENDING THE PERIOD FOR THE RENEWAL OF BUSINESS PERMITS WITHOUT SURCHARGES AND PENALTIES

WHEREAS, the recent programs of the present administration has encouraged businessmen in Marikina City to put up businesses and for existing business owners to renew the registration of their business permits;

WHEREAS, it was observed that with the filing of business permit applications commencing on the 3<sup>rd</sup> day of January and the last day thereof falling on a Friday, a shortened period for processing of business permits has resulted, which deprived business owners an opportunity to settle their business renewal;

WHEREAS, in support of the thrust of the administration to encourage and support businesses in the City, there is a need to provide an extension on the timely payment of such taxes, fees or charges, to give ample time to business owners in the City to file their respective application;

WHEREAS, Section 167 of the Local Government Code of 1991 provides that:

"SECTION 167. Time of Payment. – Unless otherwise provided in this Code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The sanggunian concerned may, for a justifiable reason or cause, extend

the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months."

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, that:

**SECTION 1.** The City Government of Marikina hereby extends the renewal of Business Permits from January 21 to March 31, 2023 without surcharges and penalties due to the increase in the number of business permits renewal and to give ample time for the filing and processing of business permits.

SECTION 2. This Ordinance shall take effect upon approval.
