## ORDINANCE NO. 51 Series of 2001

ORDINANCE PENALIZING ANY PERSON OR PERSONS WHO REMOVE, ALTER, TAMPER, DESTROY AND THE LIKE, NOTICE OF CLOSURE AND/OR CEASE AND DESIST ORDER ISSUED BY THE CITY GOVERNMENT OF MARIKINA

Introduced by: Councilor ROBERTO C. PONCE And Vice-Mayor DEL R. DE GUZMAN

WHEREAS, R.A. No. 7160 of the Local Government Code of 1991 provides that, the City Government shall issue licenses and permits and suspend or revoke the same for any violation of the conditions upon which said licenses or permits had been issued x x x;

WHEREAS, some businessmen who secure permits and license operating in this City, violate conditions set forth therein;

WHEREAS, despite notice of closure and/or cease order issued by the city government, some businessmen are able to continue to operate and defy the closure order by removing, destroying, tampering and altering the notice or posted order;

WHEREAS, the City Government of Marikina deems it necessary to impose reasonable fines and penalties to avoid illegal operations of some establishments;

NOW THEREFORE, BE IT ORDAINED AS IT HEREBY ORDAINED by the CITY COUNCIL of MARIKINA, in session duly assembled that;

SECTION 1. It shall be unlawful for any person or persons operating a business within the city for removing, altering, destroying or tampering notice of closure and/or cease and desist order issued or posted by the city government.

SECTION 2. Any person or persons found guilty thereof, shall pay a fine of Five Thousand Pesos (P5,000.00) or an imprisonment for a period of One (1) year, or both at the discretion of the court.

SECTION 3. Any ordinances which are inconsistent herewith, are hereby repealed and modified accordingly.
