ORDINANCE GRANTING AN EXTENSION OF DEADLINE FOR THE PAYMENT OF REAL PROPERTY TAX, BUSINESS PERMIT FEES AND PUBLIC MARKET STALL RENTALS UNTIL APRIL 5, 2024

WHEREAS, the City of Marikina has set the deadline for the payment of Real Property Tax, Business Permit Fees, Public Market Stall Rentals, and Business Taxes on March 30th in accordance with the Local Government Code and applicable Ordinances;

WHEREAS, it has been observed that Holy Thursday, March 28, 2024, marks the beginning of the Holy Week, a significant religious observance for many residents of the City of Marikina;

WHEREAS, it is recognized that during Holy Week, beginning on Holy Thursday, taxpayers may not be able to settle their dues on time due to work suspension in light of the regular holidays;

WHEREAS, to promote public convenience and ensure efficient tax collection, there is a need to grant an extension of the deadlines for payment of Real Property Tax, Business Permit Fees and Public Market Stall Rentals;

NOW THEREFORE BE IT ORDAINED, AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA, in session duly assembled that:

SECTION 1. The deadline for the payment of Real Property Tax, Business Permit Fees and Public Market Stall Rentals, which was initially set on March 30, 2024, is hereby extended until April 5, 2024.

SECTION 2. All taxpayers are hereby granted an extension until April 5, 2024, to settle their dues for Real Property Tax, Business Permit Fees, and Public Market Stall Rentals, without incurring any penalties or surcharges.

SECTION 3. The City Treasurer's Office and other relevant departments are directed to disseminate this ordinance through appropriate channels to ensure that all taxpayers are duly informed of the extension of deadline.

SECTION 4. This ordinance shall take effect immediately upon its approval.
