ORDINANCE REGULATING THE OPERATION OF VULCANIZING SHOPS IN THE CITY OF MARIKINA

WHEREAS, the current administration of Marikina City aims to restore road and sidewalk discipline and order in our community;

WHEREAS, the City Government of Marikina is aware that traffic is one of the biggest problem today in our city and the whole of Metro Manila;

WHEREAS, Section 16, of the Local Government Code of 1991, provides that,

"Every local government unit shall exercise the powers expressly granted, Those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.xxx"

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the SANGGUNIANG PANGLUNGSOD of MARIKINA, in session duly assembled, that;

SECTION 1. The City Government of Marikina hereby regulates the operation of vulcanizing shops within the city.

SECTION 2. The following requirements for the operation of vulcanizing shops shall be imposed;

- 2.1 The minimum area requirement for vulcanizing shops should be at least (20) twenty square meters working area with at least (1) one vehicle parking provision.
- 2.2 Repair services on public parking area, roadside and sidewalk are strictly not allowed.



- 2.3 No structure, equipment/machinery, or vehicles abutting unto public streets or sidewalk that affects and obstruct the flow of traffic and pedestrians.
- **SECTION 3.** All existing vulcanizing shops with non-conforming with minimum area requirement of twenty (20) square meters shall be given up to December 31, 2017 to comply with all the provisions of this Ordinance or owners/operators of the said business shall plan the phase out or relocate its operation within the date stated above.
- **SECTION 4.** The Philippine National Police-Marikina (PNP-Marikina), City Traffic Management Development Office TMED, Office of Public Safety and Security (OPSS), Barangay Tanod and Bantay-Bayan operatives are hereby directed to monitor all vulcanizing shops in the city and apprehend any violators and for the strict implementation of this Ordinance.
- **SECTION 5. PENALTY CLAUSE.** Vulcanizing shops owners/operators found to have violated this Ordinance shall be penalized, as follows:

a. FIRST OFFENSE - P1,000.00 b. SECOND OFFENSE - P3,000.00

c. THIRD OFFENSE - Revocation of Business Permit and

permanent closure of business establishment

SECTION 6. SEPARABILITY CLAUSE. Should any part of this Ordinance shall be declared unconstitutional or invalid, the rest of the provisions which are not affected thereby, shall continue to be in full force and effect.

SECTION 7. EFFECTIVITY CLAUSE. This Ordinance shall take effect fifteen (15) days from its approval and posting.
