## ORDINANCE NO. 049 Series of 2018

ORDINANCE PROVIDING FOR THE INTEGRATION OF BARANGAY CLEARANCE FEE TO THE BUSINESS PERMITS AND LICENSING SYSTEM UNDER SEC. 11 OF THE R.A. NO. 11032 ALSO KNOWN AS EASE OF DOING BUSINESS AND EFFICIENT GOVERNMENT SERVICE DELIVERY ACT OF 2018.

WHEREAS it is a policy of the City to continuously exert effort to improve effectiveness and efficiency in the delivery of the basic services, facilities and processing of business transactions;

WHEREAS in 2009 the City implemented a Computerization Project on Development of Integrated Revenue Collection and Management System, the Business Permit and Licensing System, Real Property Tax System and Financial Management System;

WHEREAS in 2011 the City Council of Marikina passed Ordinance No. 72 Series of 2011 amending Ordinance No. 286 Series of 1998 entitled "Ordinance providing for the classification of businesses operating in the City of Marikina that are subject to issuance of barangay clearance and prescribing the rates of payment to be imposed thereon;

WHEREAS on August 30, 2016 the Department of Interior and Local Government Department of Trade and Industry and the Department of Information and Communications Technology issued a Joint Memorandum Circular No. 01 Series of 2016 a revised standard in processing business permits and licenses in all cities and municipalities;

WHEREAS on May 28, 2018 the Senate and House of the Representatives of the Philippines in Congress released Republic Act No. 11032 known as Ease of Doing Business and Efficient Government Services Delivery Act of 2018.

NOW, THEREFORE, BE IT ORDAINED AS IT HEREBY ORDAINED by the CITY COUNCIL of MARIKINA is session duty assembled that:

SECTION-1. This Ordinance covers only business establishments within the City of Marikina.

SECTION 2. For New Business Application, the applicants shall go to their respective barangays where the business is located for registration and to acquire their barangay clearance for business.

SECTION 3. To effect the one-time assessment of fees and charges and one-time payment, the barangay clearance fee shall be integrated by the City to its system and incorporated to its Billing and Permit during the renewal of business with rates based on Sec. 1 and 2 of Ordinance No. 72 Series of 2011.

**SECTION 4.** The barangay clearance fee collected shall be remitted by the City thru the City Treasurer's Office on a monthly basis at the PHILIPPINE VETERANS BANK located at G. Fernando Ave. Branch, San Roque, Marikina City.

**SECTION 5.** The City thru the City Treasurer's Office shall furnish the BARANGAYS thru its Barangay Captain a report of the remittances made indicating the name of the establishment and corresponding Official Receipt as basis for collection.

**SECTION 6.** *Penalty Clause.* Any person who violates this Ordinance shall, upon conviction, be punished under Section 22 of the R.A. NO. 11032 known as EASE OF DOING BUSINESS AND EFFICIENT GOVERNMENT SERVICE DELIVERY ACT OF 2018.

SECTION 7. Effectivity. This Ordinance shall take effect starting January 01, 2019.
