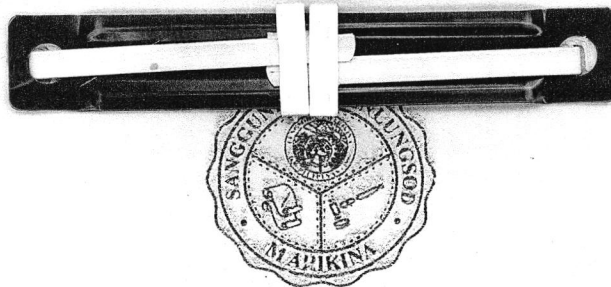

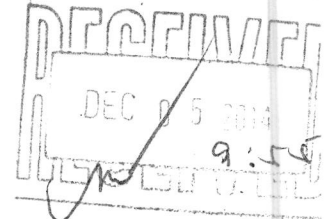

ORDINANCE GRANTING DISCOUNTS ON BUSINESS TAX AND REGULATORY FEES
TO SENIOR CITIZENS WHO ARE ENGAGED IN OR CONDUCTING BUSINESS IN
THE CITY OF MARIKINA

WHEREAS, by virtue of Republic Act No. 7432, otherwise known as the Senior Citizen Act and Republic Act No. 9257, otherwise known as the Expanded Senior Citizens Act of 2003, senior citizens are accorded the rights, responsibilities and privileges of the elderly;

WHEREAS, some senior citizens of Marikina City have invested part of their financial benefits derived from their retirement in fruitful endeavor, and to some, as a productive means of spending their idle time, and thus, help alleviate their economic needs;

WHEREAS, as an additional privilege to the senior citizens of Marikina, the City Government of Marikina hereby grants discounts on business tax and regulatory fees to senior citizens who are engaged in or conducting business in the City, pursuant to Section 192 of the Local Government Code of 1991 which stipulates that, "*Local government units may, through ordinances duly approved, grant tax exemptions, incentives or relief under such terms and conditions as may deem necessary*";

BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the CITY COUNCIL of MARIKINA, in session duly assembled, that:

SECTION 1. Senior citizens of Marikina City who are engaged in or conducting business within the City are hereby granted discounts on business taxes and regulatory fees, subject to the following terms and conditions:

- (a) The senior citizen is a resident of Marikina.
- (b) He or she possesses a business permit and license to operate from the Business Permit & Licensing Office of Marikina.

SECTION 2. To be entitled to the discounts, the senior citizen shall present his or her Senior Citizens Identification Card (ID) issued by the Office of the Senior Citizens Affairs (OSCA) of Marikina.

SECTION 3. The Business Permits & Licensing Office of Marikina is hereby tasked to implement this Ordinance.


SECTION 4. This Ordinance shall take effect upon its approval.
