
**WHEREAS**, there has been a reported increase in the circulation of counterfeit or spurious PWD IDs in Metro Manila, including Marikina City, which undermines the integrity of the system designed to support individuals with disabilities;

**WHEREAS**, the proliferation of fake PWD IDs not only affects the rightful benefits of PWDs but also poses a risk of revenue losses for businesses due to potential tax evasion schemes associated with the misuse of these counterfeit IDs;


**WHEREAS**, it is imperative for business owners and managers to be vigilant and proactive in identifying and reporting instances of spurious PWD IDs to ensure compliance with the law and protect the interests of legitimate PWDs;
